# Governor's Report—Scott Breneman

## East Region National Council of Corvette Clubs

### September 27<sup>th</sup> Governors Meeting

We met at The Holiday Inn in Grantville with 21 Regional Executives and Governors in attendance.

The East Region 2025 Budget vs. Actual was reviewed. There were several loose ends from the ER weekend in Morgantown that will be rectified before our next meeting.

The Future Corvette Owners Association has a new Website and Store that can be reached by a link on the ERNCCC site.

We are starting an East Region Newsletter. Jon Borcik will be the editor. Send any contributions to Jon. This will be sent out to East Region members with info on the following month's activities and other information.

John Cantelmo made a note that members of a host club holding a car show should not compete with visiting members. There was a discussion on this saying we simply need to be fair across the board.

Scott Fredericks reported that The East Region has 2,164 members. Nationwide there are 233 clubs with a total of 17,464 members.

The NCCC dues increase was passed at the St. Louis Meeting.

There was more discussion about eliminating plastic membership cards to save about \$20,000. We also discussed reducing the St. Louis in-person meetings from 4 to 3 per year to save about \$30,000. A Zoom meeting could be used for the 4<sup>th</sup> meeting. We also discussed producing an online copy of Blue Bars through the website and eliminating the published version to save about \$10-\$15,000 per year. I'm in favor of all these changes as a method to reduce the national budget deficit. If you feel differently, please let me know.

There is a new map being created to let perspective NCCC members locate their closest club.

There was the addition of a competition category called Time Trials. This could be run with another organizations track day. It could not be run in a "HPDE" or "Track Night in America" format. I will be following this and let our club know of any local events.

## National Corvette Museum Announces New Collections Facility to Preserve Historic Corvette Cars and Artifacts

**BOWLING GREEN, KY (October 14, 2025)** – The National Corvette Museum announced today a major expansion to protect and grow its renowned Corvette collection. The new 66,000-square-foot Collections facility, set to open in Fall 2026, will serve as the future home for some of the world's most important historic Corvettes, Corvette artifacts, and Corvette preservation efforts.

Located in Bowling Green, Kentucky, on the National Corvette Museum Campus, the new Collections facility will significantly increase the Museum's capacity for vehicle preservation, small artifact conservation, and long-term storage, while also supporting public education and guest engagement. Once complete, the building will offer behind-the-scenes tours for visitors looking to explore Corvette's past in new ways, offering unprecedented public access to the Museum's collection.

### Why We're Expanding: Honoring Historic Vehicles Like Neil Armstrong's Corvette

A key reason behind the National Corvette Museum's expansion is the strategic growth of its vehicle collection, which requires the highest standards of preservation. One example is the recently donated 1967 Corvette Sting Ray once owned by astronaut Neil Armstrong.

Years before he walked on the Moon, Armstrong was commuting to NASA in a Marina Blue coupe powered by a 427-cubic-inch, 390-horsepower V8, highlighting one of the many ways that America's Sports Car has a direct connection to one of the most extraordinary chapters in American history.

"This vehicle is a prime example of the need for a new facility," said Robert Maxhimer, Director of Curatorial Affairs and Education at the National Corvette Museum. "When a Corvette with a story like Neil Armstrong's comes through our doors, it deserves to be cared for in a space that is built to honor its legacy. This expansion ensures we can physically preserve the vehicle while protecting its history for future generations to enjoy and learn from."

The facility is being built to support the growth of the collection for decades to come, allowing the Museum to accept additional rare vehicles and historically significant materials that tell the full story of Corvette design, innovation, racing, and culture. It will also provide the Museum with additional exhibition space, enhancing storytelling and offering the behind-the-scenes experiences that Members and guests value.

### The Future of Corvette Preservation Begins Now

As part of the drive to build the new collections facility, the National Corvette Museum has secured \$2.1 million in funding commitments to the capital campaign supporting this project.

Longtime supporters of the National Corvette Museum, Mary and Ivan Schrodt, have generously pledged \$1,000,000. In recognition of their gift, the Vehicle Collections Gallery will be named in their honor. Michael LaRocca, National Corvette Museum Board Chair-Elect, has pledged \$500,000 to name the Atrium Lobby the Michael LaRocca and Family Atrium, where all guided tours of the facility will begin. Melanie and Tim McMichael & Family, known philanthropists and longtime supporters of the Museum, have pledged \$500,000 to name the McMichael Family Preservation Center, as well as the Glenn and Andrea Johnson Heritage Conservation Lab.

This contribution builds on their previous investment in 2021 that supported the McMichael Family Education Center. An additional \$100,000 gift has also been secured from an anonymous donor.

The new Collections facility strengthens the National Corvette Museum's campus-wide approach to celebrating America's Sports Car. The Bowling Green Assembly Plant, where every Corvette has been built since 1981, is located just across the street. The NCM Motorsports Park, where guests can experience Corvette performance firsthand, is also part of the Museum campus and sits directly across Interstate 65. Construction of the new Collections facility will also bring NCM Insurance one step closer to returning to the Museum campus. Once complete, this addition will allow visitors to engage with the full arc of Corvette ownership, history, and performance in a single location.

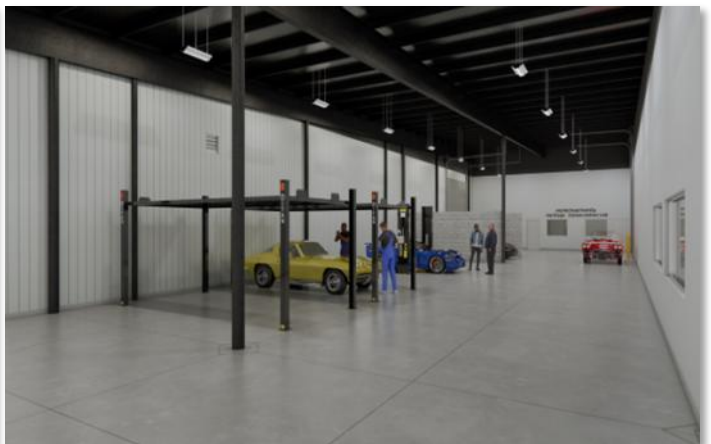

The following are the award categories with a description of each:

**LCCC Lifetime Achievement Award**—One person, recognized annually, for the consistently outstanding leadership, participation, involvement and contributions to the club throughout their membership tenure. This award is based on achievement not attendance. Recognition should be limited to those individuals who have been members for 15 years or more.

**LCCC Outstanding Worker(s)**—Recognition of an individual or couple that consistently 'steps-up' to help in club activities throughout the year. Often, they go above and beyond in their efforts.

**LCCC Unsung Hero**—Recognition of an individual member that typically 'flies below the radar,' but consistently shows up, [participates and gets involved in a variety of club activities.

**Outstanding Leader(s)**—Recognition for an individual or couple who both actively participate in the club's various activities and events, including taking leadership/organizing roles in a variety of activities or events.

**Outstanding New Member**—Rookie recognition of an individual member who has recently joined the club (since July or the previous year). These new members have jumped in 'headfirst' to participate in activities or events and actively support the club.

Remember that these awards reflect the 2025 club year. To nominate members for these categories, we will again be using a Survey Monkey. Please include a brief comment as to why you believe your nominee deserves to be recognized. The link for the survey will come out through an E-mail blast.
