In the headline to this article, I noted "February Already?". It is hard to believe we are a month into the new year. This means things we already know dates of are going to come quick. Our first autocross is three and a half months away. The Stauffers show is roughly four months out. The 2022 NCCC Convention in Atlantic City is four and a half months from now.

As always, we will need members to help at these events so be on the lookout for sign-up sheets to start circulating at the next meeting. Somewhere in the next four to five months will also be the spring Adopt-A-Highway and typically there will be at least one cruise or get-together so prepare to fill up your calendar.

In just a few months, we will begin selling our Raffle Tickets for a new 2022 Corvette Stingray. We had a

great event last year and this year should be no different. We are extraordinarily fortunate to have a wonderful sponsor in Whitmoyer Auto Group that makes this activity a success.

it #1 for why we need our "Stinkin' Wimer's Rule" (3), followed by Barry Whitcraft at \$18K. On the individual cars in our contest, "close but no cigars" ruled the roost on the first three:

• Lot 122.1, the 1996 Collector's Edition, sold for \$17,000 – with predictions by Sharon Roberts and Rookie Eileen Scotten a scant \$500 too high;

• Lot 126.1, the 1986 Indy Pace Car Roadster, hammered at \$13,500 – and "oh so close" \$500 misses were registered by the two Mooney's, the two Marley's (Brad and Betty, SW Rule Exhibit #2), and Susan Gerhart;

• Lot 150.1, the 1995 Indy Pace Car Roadster, sold for \$34,000 – with \$2000 misses claimed by Barry Whitcraft and the two Fox's (Marvin and Ruth, SW Rule Exhibit #3).



Our fourth car for the evening (Lot 162), the 1992 ZR-1, resulted in our first two "Bull's Eyes" of the contest when it found a new home for \$37,000, precisely predicted by Kelly Sylvester and Barry Whitcraft. Note that former LCCC member Tom Henman will be glad to know that MAYBE the C4 ZR-1's are finally starting to gain some value...

On the team front, Scott "I ain't no trash-talker" Lewandowski's "Four Flats and a Spare" secured the early lead on the rest of the field, with Ken Unger's "Headlights" currently in 2nd. Of course, it's early, and no lead is safe in this contest.

DAY TWO—Our Rookies Are Showing Everyone How It's Done.

If you haven't already noticed, our field of Rookies this year is very limited, as we only have three LCCC members who were willing to "take the plunge" - longtime member Gary Lintner, recent addition Carl Lally, and newbie Eileen Scotten. I'm not sure what kept everyone else away; maybe the lack of an "in-person" January meeting, or perhaps cumulative annoyance at my repetitive emails encouraging everyone to "jump in". Whatever the cause, our Rookie field is limited to these three. And it's already clear to our BJ TPIR veterans that these three "got game"...

After the first eight cars in our 32 car docket, our 31 "veterans" have racked-up an average penalty of \$212,548. Our Rookies, on the other hand, are averaging barely HALF of that, at \$112,867. Leading the way is Gary Lintner at a paltry \$61,900, sitting squarely in second place behind Sue Mooney - who's meager two-day total of \$57,000 defies all sensibility. Eileen's total of \$105,600 has her sitting securely on our current leader board, and Carl's \$171,100 ain't too shabby either. On the "veterans" side, notables still in 5figures include Scott Kingsboro at \$86,500, Clyde Mooney just \$1K higher, Barry Whitcraft at \$89,000, and Ken Unger at \$95,000.

While the average score of our field is interesting, as my 11th grade math teacher used to tell us, "You can't always tell much from averages. The average American has one testicle. What

does that tell you about the "average" American?" While our field's AVERAGE penalty is a hair over \$200K, our spectrum of scores ranges from Sue Mooney's silly low to Val Cifuni's scary high. As the inaugural member of the "Million Dollar Club", Val may have set a TPIR record for the earliest entry into this vaunted institution. While it's guaranteed that membership in this less-than-exclusive organization will grow over the coming days, Val may have the entire clubhouse all to herself until sometime on Friday. Try not to get too lonely...

Here's a quick recap of the individual car action:

• Lot 368, the 2004 Commemorative Edition ZO6, sold for \$31,000 – Four contestants were just a whisker away with \$1000 misses: Sue Mooney, Jesse Landis, Mary Anne Lewandowski, and Bob LaFata. At the other end, Val's \$90,000 guess blessed her with a \$177,000 penalty.

Lot 385.1, the first of our night's two 1975 L82's, hammered at \$22,000 - The ladies once again showed the way, as Joan Steidle scored our contest's third Bull's Eye with a perfect bid, followed by Sue "who else" Mooney only \$500 too high, and Marleen Foreman and Rosemary LaFata each bracketing the sale by \$1000. Val, on the other hand, enjoyed a \$204,000 addition to her score, when she read on Facebook somewhere that hidden inside this car were the 18 minutes of missing recordings from Nixon's Watergate tapes. Val, ya can't believe everything you read on Facebook...

• Lot 421.2, the 2020 1LT Stingray from the GM Heritage Collection, sold for \$99,000 -

Underbids were the primary order of the day on this one, as the vast majority of our field (your Gamemeister included) undervalued – and in some cases dramatically undervalued – what this car would sell for. Ruth Fox and Eileen Scotten didn't take the bait, and missed by a scant \$1000.



Lot 475, the 1975 L82 Survivor, found a new home for \$45,000 – This one racked-up our largest collective penalty so far, with an average hit to the field of just over \$50K. Four-digit misses were few, led by Eileen at \$3000, Paul Wenger at \$4000, Steve Witmer and Scott Lewandowski at \$5000, Gary at \$7100, and Barry Whitcraft at \$8000. Val and Henry Cifuni's combined total of \$360,000 put Val into the aforementioned "Million Dollar Club", and left Henry wondering when he would be joining his wife again. Don't despair, Henry, you're almost halfway there ...

On the team front, the "Four Flats and a Spare" widened their lead significantly over the field, with the "Taillights" and the "Headlights" battling it out for second. Please note that yesterday "Team" results had the daily total for Tuesday total hidden (you'll remember that due to COVID, the 2021 version of our contest occurred in March, Barrett-Jackson didn't have enough cars for a Tuesday docket, so I just hid that row from view). I've corrected the way it is displayed. As Thursday rolls around, prices should begin to escalate as the merchandise gets a little more exclusive and a lot more serious. We've got six more candidates crossing the block tonight, so the action should be fierce and the scores should climb. Additional trash talking is optional...

DAY THREE—Sharpshooters Galore, and A True Love Story (?).

Thursday was a day unlike any other in TPIR history – a total of ELEVEN Bull's Eyes were recorded by our TPIR sharpshooters over a meagre six car field! Steve Witmer, Marvin Fox, Sue Mooney, and Kelly Sylvester each grabbed one; Scott Lewandowski and Betty Marley each nabbed two; and Scott Kingsboro, truly "KINGsboro" of the Day 3 aforementioned crack shots, registered THREE perfect predictions!! In fact, Scott's trivial \$30,000 addition to his score for vesterday's six cars vaulted him WAY into first place, as the leaders from the first two days went whizzing by. With a 14 car total of only \$116,500, Scott leads the rest of our top five consisting of Clyde Mooney (\$190,500), Scott Lewandowski (\$231,500), Steve Witmer (\$256,500), and Sue Mooney (\$257,000).

Following Val's "Reply All" email throwing her hubby under the bus for her astronomical two-day score, Henry obviously decided that leaving her alone in the Million Dollar Club to stew and fester was not a wise course of action. Demonstrating resolve that only true love can generate, Henry quickly piled-up six figure penalties on the first two cars of the evening and joined his better half in our not-so-exclusive MDC society. This somewhat weird PDA ("public display of affection", for those of you not up on the younger generation's texting acronyms) obviously triggered some kind of symbiotic love dance between the two of them, as both of them quickly twirled and thrust themselves into the TWO MILLION DOLLAR CLUB by evening's end. True love has no bounds...

With these major story lines behind us, here's a quick "car-bycar" recap of last night's action:

• Lot 754.1, the 1954 Roadster, selling for \$84,000 – While no Bull's Eyes were recorded, the ladies once again led the field with near misses, as Betty Marley was just off the mark only \$1000 too high, followed by Mary Anne Lewandowski \$2K higher. Sixfigure misses were somewhat plentiful, led by the two lovebirds noted above.

• Lot 757.1, the 1957 FI Roadster, sold for an even \$100,000 – Betty and Scott K recorded Bull's Eyes, with Mary Anne, Brad Marley, Barry Whitcraft, and yours truly the only ones recording 4figure misses. Henry led the field with a \$300K hit, followed by Joan Steidle at \$174K and Sharon Roberts at \$158.1K.

• Lot 761, the 1961 Roadster, hammered at \$120,000 – Sue Mooney registered the lone Bull's Eye, with "oh-so-close" \$2K misses by husband Clyde and Kurt Steidle not far behind. Henry and Val's waltz turned into a fullblown Rumba as they divided nearly \$600K between them, with Sharon trying to cut-in at some point with a \$245K penalty.

• Lot 790, the 1970 LT1 highlydecorated Coupe, finding a new home for \$70,000 – Betty Marley once again cracked the Bull's Eye code, joined by Scott Lewandowski, as both had perfect pre-

dictions. Ali Murphy and Jan Gerhart each missed by \$500, the thinnest of slivers. At the other end, 6-digit misses were few; you can probably guess who lead the hit parade...

• Lot 808, the 2018 ZO6 Coupe, sold for \$92,000 – Scott K and Marvin Fox recorded Bull's Eyes, with measly \$2K hits logged by Autumn Kingsboro, Kurt Steidle, and Sue Mooney. For the first time in two days, not a single 6figure penalty was recorded. Everybody celebrate!



Lot 816.1, the 1966 L72 Coupe, concluded our evening at \$90,000 – Battle fatigue must have made this one an easy mark, as four TPIR sharpshooters hit the nail on the head – Kelly Sylvester (her second overall), Scott K (his third of the evening), Scott L (his second of the evening), and Steve Witmer. After taking a break on the previous car to catch their breath, Val and Henry broke into some kind of bizarre Watusi-Twerking- Break Dance thing to finish the evening, sharing over \$700K in penalties and gate crashing into the Two Million Dollar Club! Congratulations!

On the team competition, based on the solid contributions from each of the team members (rather than Steve's trash talk), the "Taillights" vaulted themselves into the lead over the "Headlights", with "Four Flats and a Spare" falling from first to third, and the "Prognosticators" a hair behind.

Two notes of interest:

• Up until now, all cumulative scores have been based on the "actuals", and did not include the "Get Out of Jail Free" deduction. Starting tomorrow, I'll switch gears when reporting total scores on both the individual and team standings. If you're wondering why I wait until the last two days to do this, you'll quickly figure it out as prices (and penalties for errant prognostications) escalate tonight and tomorrow.

So Friday is here – the big money has arrived in Scottsdale, and the serious bidders have begun pushing their way to the front of the auction gallery, moving the posers from the first three days back to the cheap seats. Prices will escalate, fortunes will be spent, and scores throughout our field will escalate. Grab a cold one and hold onto your seats – the real fun starts TODAY!

DAY FOUR—An Auction Floor Full Of Buzz Lightyears.

For those wondering when prices were REALLY going to take off at Barrett-Jackson Scottsdale, Friday's action provided plenty of evidence that there a LOT of people in this country that simply just don't know what to do with all of their money. Prices moved towards the stratosphere throughout the day, as one uber-wealthy Buzz Lightyear after another kept outbidding their weaker challengers on the auction floor. By the end of our contest's docket on Friday, prices clearly skyrocketed to Infinity and beyond!

As a result, penalties and total scores moved significantly higher throughout our field, and not just with the usual suspects of the first three days. Screams were heard, tears were shed, expletives were shouted, and new previously-unthinkable barriers were broken. With that in mind, here's the "car-by-car" recap of the action:

Lot 949, the 1968 Multiple Award Winning Roadster, sold for \$37,000 - Clearly the "bargain" of the day, as every one of our contestants except ONE (Jan Gerhart) predicted that this car would sell for more (or A LOT more, in some cases)! Scott Lewandowski missed by a scant \$3000, with Jan next incurring a \$5000 hit. Scott Kingsboro, who crushed the previous day's action with THREE BULL'S EYES, surprised everyone by leading a group of 5 others registering Š200K+ penalties. Once again these paled, of course, to our two love birds Henry and Val Cifuni, who decided to "go Dutch" on this one - adding an additional \$1,008,000 in total penalties, and splitting it almost evenly.

• Lot 969, the 1970 Multiple Award Winning LT1 Roadster, hammered at \$75,000 – Our sharpshooters once again emerged, as three competitors scored perfect Bull's Eyes – Barry Whitcraft (his 2nd), Rookie Eileen Scotten, and the Captain of the "Prognosticators", Jesse Landis. Throughout the rest of our field penalties were generally light, with Brad Marley (\$120K), Kelly Sylvester (\$201K), and Henry (\$600K) our only 6-figure participants.

• Lot 1019.1, the 1969 Coupe, sold for \$140,000 – Jesse bagged his second Bull's Eye in a row, and Kelly redeemed herself with only prediction only \$4000 too low. Two-thirds of our field registered 6-digit additions to their score, and Henry became

the inaugural member of the Three Million Dollar Club.

• Lot 1057, the 1967 Tri-Power Roadster, skated through at \$95,000 – Susan and Jan Gerhart collected our only 4-digit penalties, at \$5000 and \$7000 respectively. While not garnering the biggest hit to their score (guess who held that distinction?), Sharon Roberts did learn the secret handshake and gained entrance into the Million Dollar Club. Don't despair, Sharon, company is not far behind...



Lot 1059, The 1969 L71 NCRS Top Flight Coupe, sold for \$150,000 – Jesse scored again with his THIRD Bull's Eye of the evening, to tie Scott Kingsboro for the overall lead in that category! The three Kingsboro's -Scott, Autumn, and Janelle were obviously in cahoots, as they all added paltry additions to their scores (\$10,000, \$5000, and \$3000 respectively). Kelly was the lone other contestant with a 4 -digit hit (\$5000), as the rest of our field incurred 5- and 6- digit additions. Not content with having the Three Million Dollar Club all to himself, Henry opted to expand his empire and initiate the Four Million Dollar Club as well.

• Lot 1077, the 1958 Resto-Mod Roadster, found a new home for \$160,000 – Conspiracy theorists will have a field day, as once again the Kingsboro's led the way with \$4000, \$5000, and \$10,000 hits to Janelle, Autumn, and Scott. The \$5000 miss was matched by Steve Witmer, Kelly, and yours truly. At the other end, Sharon is no longer lonely as Rookie Gary Lintner, who showed so much early promise, climbed into the Million Dollar Club, joined by Ken Unger. Of special note is Rookie Eileen Scotten's \$870,000 penalty, a new record for a single car in this edition of BJ TPIR!

Lot 1103, the 2022 IMSA Edi-• tion C8, hammered at \$300,000 -This one ALMOST invoked the "Kevin Hart Rule", as 29 of our 34 contestants recorded their highest penalty-to-date on this car, and these hits now occupy each person's "Get Out Of Jail Free" deduction. EVERYONE "enjoyed" 6-digit additions, and Henry extracted a little bit of revenge on the rest of the field by registering our closest guess and only added \$170,000 to his score!! Val moved into the Three Million Dollar Club, and the following people ioined Sharon. Garv. and Ken in the MDC: Kelly, Marleen, Susan, Kurt, Joan, Barry, Eileen, Paul, Marvin, Rosemary, Ali, and Carl. Phew!!

• Lot 1140, the 1961 FI Survivor Roadster, sold for \$120,000 – A degree of normalcy returned late in the evening, with Craig Foreman registering our last Bull's Eye of the evening with a perfect prediction. Joan Steidle was next in line with a \$5000 hit, and Steve Witmer was just \$2K back at \$7000. Feeling the pressure, Henry moved into the FIVE Million Dollar Club, and Brad Marley barely squeaked into the Million Dollar Club by only \$500.

So where do things stand? Heading into "Big Money Saturday", Scott Kingsboro has a firm grasp on 1st place at \$460,500. Steve Witmer holds second place \$188K back, with Autumn Kingsboro and Scott Lewandowski a few whiskers further behind. Eleven others have so far managed to evade the notoriety of joining the Million Dollar Club, but I have a hunch that distinction will be short lived once the action starts later today. The Bull's Eve contest is a real battle. with a total of TWENTY registered so far, led by Jesse Landis and Scott Kingsboro with three apiece. Carl Lally leads our Rookie race over Gary and Eileen, but this one is still too close to call with Saturday's action still on tap. On the team front, the "Taillights" have widened their lead on the entire field, with the "Headlights" and "The Skidmarks" next in line, both hoping to make a late move.

So Saturday is here - the REALLY big money has now arrived in Scottsdale, with the private jets lined-up at the Phoenix airport ready to whisk their owners away after the final gavel falls (don't for a minute think that they might ACTUALLY drive their purchases back home). Bidding on the auction floor will be fierce, and the competition for the coveted prizes and bragging rights that go along with "The Price Is Right" will certainly be second to none. So grab a bunch of your favorite beverages and settle-in for some exciting action. That's my plan, and I hope it's yours as well...

DAY FIVE—Testosterone Overload Wreaks Havoc AT Barrett-Jackson Scottsdale.

If you managed to tune-in to the entire broadcast, rather than ignoring the whole thing completely or simply paying attention whenever one of our contest vehicles happened to cross the stage (several of which went by

when the folks at Barrett-Jackson and/or the programmers at FYI and/or the History Channel decided that this was a good time to subject the eyeballs watching the broadcast to some silly advertisement for ladies lingerie (savegex.com, if you are interested I), a variety of hair restoration pharmaceuticals, and/or male enhancement products), you would have seen what transpires with sale prices when you combine WAY TOO MUCH MON-EY with WAY TOO MUCH TES-TOSTERONE - they go BONK-ERS!!! Prices throughout the day were just short of institutionally insane, and the Barrett-Jackson scorekeeper had a difficult time keeping up with the "Top 10" sales of the day. The hammer prices for our fourteen candidates (ten contest vehicles, plus four "Bonus Cars") with one or two exceptions did not deviate from the overall trend, resulting in astronomical penalties for our shell-shocked competitors. When the final stats are in, I expect that the results from Barrett-Jackson Scottsdale will add a full 1 or 2 points to the Q1 US Inflation rate. Fox News is already projecting another hit to President Biden's approval ratings.

With that intro as a backdrop, here's the "car-by-car" recap of the action:

• Lot 1276, the Duntov Award Winning 1956 Roadster, sold for \$120,000 – Craig Foreman followed his Friday end-of-the-day Bull's Eye with one on the first car of our Saturday docket, joined by Jesse Landis (his fourth!), Autumn Kingsboro, and Bob LaFata. At the other end, Henry Cifuni again set the mark at \$615,000, followed by Brad Marley and Kelly Sylvester at \$270,000. Sue Mooney, Jim Roberts, Jan Gerhart, both Betty and Brad Marley, and Mary Anne Lewandowski all picked-up their 2022 membership cards to the Million Dollar Club.

Lot 1303, 1963 Split Window Coupe, hammered at \$350,000 -On a car where 29 of our 34 contestants racked-up 6-figure penalties (most of which started with a "3" or higher), Autumn Kingsboro led the five players that DIDN'T need to buy a vowel with her second Bull's Eye in a row!! To nobody's surprise, the two other people that hang their hats under the same roof fell into that 5player category, along with Rookie Gary Lintner and Val Cifuni (way to go, Val!!). When the dust settled, this car set a new high water mark for bad predictions, with over \$16.6 Million of total penalties applied to our entire field. Also to nobody's surprise, all remaining players that DO NOT inhabit the home directly underneath the aforementioned roof identified earlier joined their fellow competitors as members of the Million Dollar Club. Don't be surprised if an upcoming modification/expansion of the "Wimer Rule" is announced before next year's contest.

Lot 1328, 1968 L88 Coupe. sold for \$300,000 – If we thought the field's predictions were bad on the previous Lot, this one put it to shame. With \$17,549,000 in total penalties to distribute over 34 competitors, that works out to a smidgeon over \$516K per for those that are mathematically challenged. Shirking their responsibility to absorb their fair share were Clyde Mooney and Mary Anne Lewandowski, who's \$275,000 predictions resulted in relatively small \$25,000 additions to their scores. Recapping all of the bad guesses, along with their

impact on individual competitor totals, might use up all of the bits and bytes available in my computer – so suffice it to say that total scores soared.

Lot 1358. the 1958 Resto-Mod Roadster, found a new owner who will undoubtedly pay someone to pamper it at \$420,000 - Once again, our total penalties skyrocketed further, this time to a total of \$21.8 Million (that's ~\$641,000 per player). Sue Mooney at \$40,000, Clyde at \$60,000, and Jesse Landis at \$70,000 were the three lone 5-digit penalty "winners". Almost everyone else blew into one of several "Multi-Million Dollar Clubs", with Henry Cifuni initiating another permutation: this time the SIX Million Dollar Club. Of particular note is a change at the top of our leader board; after back-to-back thrashings of anyone with the last name of "Kingsboro", Jesse Landis moved into first and Sue Mooney grabbed second – and we were down to just 13 contestants that haven't entered the TWO Million Dollar Club!



• Lot 1402, the 1958 Resto-Mod Roadster, hammered at \$625,000 – There's only one thing to say – this is nuts! All together now, BLAME SUE MOONEY!! If it wasn't for Sue, who's \$450,000 penalty on this car was eclipsed by her \$525,000 penalty on yesterday's 2022 IM-SA Edition C8, we would have

invoked the "Kevin Hart" rule and eliminated this car from our contest, as every other contestant registered their "Get Out Of Jail Free" deduction on this car! Penalties totaled \$45,916,000 for the field (yeah, that's \$1.35 Million per player). Sue's \$450,000 hit was our lowest, followed by Jesse's \$550,000, and Clyde's \$570,000. The rest of the field will remain nameless to protect the guilty.

Lot 1403, the 1963 Resto-Mod Split Window Coupe, sold for \$500,000 - With a paltry \$100,000 miss - the best in the field - Jesse held onto first, followed now by Clyde, who matched Jesse's miniscule (?) 6figure penalty. Hats off to Henry C, who's \$125K miss clearly deserves mention, based on how much abuse he's endured from your Gamemeister over the first 4 days. The trio of Kingsboro's continued their dive, and are now looking up at about a dozen competitors.

Lot 1420, Alan Shepard's 1968 Corvette Roadster, hammered at \$280,000 - Believe it or not, a few months ago this car languished on E-Bay where it couldn't find a buyer at \$175.000. But somehow it's worth 60% more at Barrett-Jackson (76% more if you include the buyer's premium). Marleen Foreman was a scant \$25,000 off, followed by hubby Craig and Jesse at \$30K, and Betty Marley at \$40K. Other scores were higher, yada, yada, vada.

• Lot 1428, the 1963 FI Split Window Coupe, sold at \$195,000 – Sanity, at least a reasonable facsimile thereof, returned to the bidding with Lot 1428, and resulted in our first Bull's Eye of the evening with a perfect prediction by Brad Marley. Ruth Fox, Betty Marley, Barry Whitcraft, Jim Roberts, and Craig Foreman all registered miniscule (by recent standards) \$5000 hits. With two cars to go, Jesse held a firm hand on the lead, but 2nd was clearly up for grabs with Clyde, Sue, Jim, and Steve still in the hunt.

• Lot 1431.1, the 1967 NCRS Top Flight & Duntov Award winning Coupe, hammered at \$175,000. Jesse took a major hit to his score with a \$375,000 penalty, Steve added \$600,000 to his total, and the race tightened considerably. Jim, Susan Gerhart, Joan Steidle, and your Gamemeister managed tiny \$5000 hits. Jesse's lead still appeared secure with one car to go, but second place is wide open between Clyde, Sue, and Jim.

Lot 1441, the 2021 Cunning-٠ ham Edition Corvette Coupe, found somebody that hopefully wants to keep it at \$170,000 -Autumn Kingsboro put an exclamation point on the last vehicle in our contest with a perfect Bull's Eye bid – her third of the day! A bunch of others were close as well, and a few missed by the proverbial country mile among them Jan Gerhart with a \$1,140,000 hit; Henry with a \$2,340,000 hit (propelling him into the VERY EXCLUSIVE Eleven Million Dollar Club!); Ruth Fox with a \$5,490,000 OMG miss, and hubby Marvin with a mindblowing \$7,590,000 errant prediction (needless to say, both Fox's are VERY THANKFUL for the "Get Out Of Jail Free" deduction!)!

What a day! Everybody just take a deep breath, and wipe the sweat from your brow! This was, BY FAR, the highest individual totals in the history of our little game. Kudos to Jesse Landis who prevails in this slugfest, taking home bragging rights and the 1st place \$75 gift card. Jim Roberts finishes second and grabs the \$50 gift card, and Clyde Mooney gets third along with a \$25 gift card. On the Bull's Eve front, we had a great battle with a total of 27 perfect predictions; Jesse takes home the \$25 prize with a total of four. Gary Lintner wins our rookie award with a solid performance, and nabs a \$25 gift card as well. Steve Witmer's Taillights" take home the team trophy, and each will receive \$10 gift cards.

Our Bonus Car winners include Ali Murphy on the Buick Grand National, Marvin Fox on the Yenko Camaro AND the first 2023 ZO6 Corvette, and Rosemary LaFata on the 1969 Pontiac Trans Am; \$10 gift cards will be awarded for each winning bid.

So Saturday has thankfully come and gone, and another LCCC Barrett-Jackson "The Price Is Right" is in the books. If you couldn't tell that by the end of tonight's action (and/or fiasco, depending on your perspective), the bloom was off the rose as far as your Gamemeister was concerned. If vou're still awake when this finds it's way into your "Inbox" this evening, tonight's Powerball jackpot is \$104 million. Take a shot; you've got as much of a chance at winning as you do making any sense of this mess. If you missed this opportunity, there's another drawing on Monday.

Kelly and I look forward to seeing each of you and reliving this nightmare at the Awards Banquet and Dinner Dance in March.

1983 Corvette Analog Gauge Cluster

As we begin the year leading up to the 70th anniversary of Corvette's debut at the Waldorf Astoria in New York City, the National Corvette Museum is launching our Artifact of the Month program! Each month, our Curatorial staff will select an artifact from our collection that is connected to a significant moment in Corvette history and share its story with you. To kick off this program our Director of Collections & Curator, Derek E. Moore, presents the...

1983 Corvette Analog Gauge Cluster



Some of the greatest mysteries in Corvette's rich production history revolve around the choice to skip production on Corvette's 30th anniversary in 1983. The transition from the third-generation (C3) to the fourthgeneration (C4) Corvette was a major technological leap forward for Chevrolet and was the beginning of transitioning Corvette from being a brute American sports car to a global competitor of the European sports car market. During this major transition, every component of Corvette was being reimagined, redesigned, and reengineered – from the exterior to the interior.

An all-new look to the interior was key to this transition, and the instrument panel display was vital. The plan to bring Corvette into the "digital age" led to the development of a graphical cluster utilizing all digital read-outs and bar graphs to provide the driver with vehicle statistics quickly and cleanly.

During the earliest stages of development though, engineers discovered that generating enough light to see the readouts on the cluster was difficult and there were concerns over the dash's performance in cold climates. Therefore, an analog "backup" cluster was created, with its very standard, multiple gauge – speedometer, tachometer, oil pressure, fuel, oil temperature, voltage, and coolant temperature – layout. While functional, it was a very dated appearing cluster for this all-new Corvette. During testing at Milford Proving Grounds, both the analog and new digital dash were running in 1983 development Corvettes.

Corvette Chief Engineer, Dave McLellan, recently reflected on the development of the analog cluster for the C4 Corvette: "I was never happy with this cluster. It was always considered as a backup to the color graphic cluster. Why was I unhappy? It was uninteresting and it suffered from reflection problems. We had no intentions of using it if we could solve the problems of the graphical cluster.

The C4 was bringing the Corvette into the digital age. The instrument cluster was proposed by our Interior Design Studio led by Bill Scott. GM's AC Division planned to engineer and produce it. Its "Achilles Heel" was getting enough light through the light pipes while at the same time not overheating the display. Only recently have we seen LED bulbs made available for this application which have given the display the brightness and color expected.

Why this design? The genesis of the design was the steering wheel graphics seen in F1. And, if you think about how to best display information – information like RPMs, that can change rapidly, are best displayed as a bar graph. If they were displayed as numbers, they would look like an incomprehensible blizzard of numbers."

This 1983 analog "backup" dash, donated by Marvin Owen, is one of only two known extant examples from the development of the 1983 Corvette.

Corvette Racing—Rolex 24 at Daytona

Tough Debut in GTD PRO

Corvette C8.Rs, team soldier through to complete full 24 hours

DAYTONA BEACH, Fla. (Jan. 30, 2022) – Corvette Racing made it through a tumultuous Rolex 24 At Daytona on Sunday and gained valuable information on its Chevrolet Corvette C8.Rs in their new GT Daytona (GTD) PRO configuration.

The No. 3 Mobil 1/SiriusXM Corvette of Antonio Garcia, Jordan Taylor and Nicky Catsburg – 2021 winners in the GT Le Mans class – led Corvette Racing's charge with a sixth-place finish. It was a solid drive back from ninth place in the middle of the night when an electrical issue cost the team 13 laps in the garage.

The No. 3 C8.R is the team's full-season entry in the new -for-2022 GTD PRO class. Other than the visit in the garage late Saturday night, things ran almost like clockwork for the Garcia/Taylor/Catsburg trio.

The same couldn't be said of the No. 4 Mobil 1/ SiriusXM Corvette of Tommy Milner, Nick Tandy and Marco Sorensen. Their C8.R appeared to be the strongest of the Corvette Racing entries in the opening hours until rear contact after a restart with Sorensen at the wheel caused significant damage near the 8.5-hour mark.

Sorensen had to brake hard to keep from hitting the wayward LMP3 car, which also just missed collecting Catsburg in the No. 3 Corvette. The No. 4 team lost nearly 2.5 hours replacing the diffuser, exhaust pipes and starter, among other components. It eventually salvaged a top-10 class finish.

Daytona marked the only scheduled IMSA appearance for the No. 4 Corvette, which moves to the FIA World

Endurance Championship's GTE Pro class starting with the 1,000 Miles of Sebring (Fla.) on March 18. It is part of a combined weekend with IMSA, which will see Garcia, Taylor and Catsburg race in the Mobil 1 Twelve Hours of Sebring on March 19.

ANTONIO GARCIA, NO. 3 MOBIL 1/SiriusXM CHEVRO-LET CORVETTE C8.R – SIXTH IN GTD PRO: "This was one of those races where you wanted it to be shorter. We learned a lot and there is still more for us to learn. We had 25 or 26 stints to learn this tire. So it was a proper first real test in race conditions. We were lacking pace both days. There still was a lot to be gained. If you add some extra testing and something else, then maybe we can be in the hunt. In the last stint, I could tell we were missing a tiny bit. If we were on the lead lap, it would have taken a tiny bit for us to be competitive. We'll carry on to Sebring."

JORDAN TAYLOR, NO. 3 MOBIL 1/SiriusXM CHEVRO-LET CORVETTE C8.R – SIXTH IN GTD PRO: "Other than the alternator issues, we've had a faultless and flawless race. The strategy and pit stops have been great. It's good to see the team executing so well. It's unfortunate we had that issue otherwise we'd be fighting in the topfive somewhere. It's good to get the extra miles and it's good the guys got us back out there because we have a championship to fight for at the end of the day. We've made up some points by attrition."
