

## Breast Cancer Fundraiser

Here is our “Thanks to Our Sponsors” picture for 2024. I would like to thank Kurt Steidle for helping me with this picture. I would also like to thank the many members of the Lancaster County Corvette Club for their donations, and to remind everyone that there is still time to donate. I am on the right, and Rich Grant- my transit driver- is on the left. We will be using my new 2023 Orange Z51 Corvette again this year. Rich Grant, a new member of the Northern Virginia Corvette Club, will once again serve as my transit driver to help with the highway miles.

I am getting ready for this year’s event, which we will compete in early May. Every year we do a different route. This year, we will be leaving from South Bend, Indiana after the Wet Skid Pad Competition and then heading to the I-29 Road Course in Pacific Junction, western Iowa. From there, we will travel to Hallett Motor Racing Circuit in Jennings, Oklahoma. After Hallett, we will head to our farthest west course, High Plains Raceway Road Course, not far from Denver, Colorado. That same day, we will make a short trip to Julesburg Raceway Drag Strip for a drag strip event.

Next, we are off to Motorsports Park Hastings near Hastings, Nebraska, followed the next day by Road America in Wisconsin, and later that same day to Slinger Super Speedway Oval Track in Slinger, Wisconsin. We will then head to Blackhawk Farms Raceway near Beloit, Illinois for our final road course event, before returning to South Bend for our last competition—the Dry Skid Pad—on Saturday. That Saturday, we will also have our Awards Luncheon. Including the miles to and from South Bend and back home, the total distance will be almost 4,200 miles in just over a week.

As noted, Rich Grant will again be my transit driver, handling the highway miles, while I will do all of the competition driving. This will be my 17th One Lap of America. Over the past several years, we have raised more than \$55,000 for the Pennsylvania Breast Cancer Coalition. By making a donation, you can ride along “vicariously” with your name displayed on the top of the car while helping support a great cause.

Just for fun, we'll throw-in a few unique "non-Corvettes" crossing the stage on "Big Money" Saturday to keep it interesting for those that have stumbled along the way and are out of the running for any of our top contest honors. While there is always a core of "TPIR Diehards" making up a good portion of the field, for the 2nd year in a row we've added special "Daily Prizes" exclusively for rookies to encourage more of you to enter the game – that's right, FIVE unique prizes just for you newbies, and nobody can win more than one! And if you think your lack of Corvette-specific knowledge is a reason to sit this out – think again. For the past two years higher amounts of estrogen have been the secret to taking home "Rookie of the Year" honors, with scientific methodology such as "I really liked the color, so I guessed high" to "I thought that one was kind of ugly, so I guessed low" dominating the prediction process. This event is always a great gathering, where friendship and good-natured ribbing of fellow competitors is as widely shared as the potluck food and drink. More details to follow.

### Joseph Newgarden Receives 2026 Corvette ZR1 Through R8C Delivery at the National Corvette Museum



2023 Indianapolis 500 winner Josef Newgarden visited the National Corvette Museum this week to take delivery of his 2026 Corvette ZR1 through the Museum's R8C Delivery program. The two-time NTT INDYCAR SERIES Champion and Team Penske driver accepted the handoff on Corvette Boulevard, where thousands of Corvette owners have marked the start of their own driving legacy.

The R8C Delivery program places each new Corvette owner into the history of the brand by making the Museum part of their first day behind the wheel. The process includes a guided orientation with a Corvette delivery team member, an in-depth vehicle review, and an official presentation on the Museum floor. Owners receive a personalized plaque and one-year Museum membership as part of the experience.

For Newgarden, a driver known for his focus on balance, braking, and mid-corner precision, the ZR1 arrives with those same principles built into its engineering. The 2026 ZR1 is powered by a twin-turbocharged 5.5L DOHC V8. It shares its architecture with the naturally aspirated flat-plane LT6 found in the Z06 but adds twin turbochargers to deliver the most powerful Corvette engine ever offered from the factory. The ZR1 also features a carbon fiber aero system, available carbon-ceramic brakes, and a chassis calibrated for road course stability and high-speed control. Newgarden's visit to the Museum follows a long tradition of performance drivers engaging with the Corvette brand—not as a sponsorship, but as a shared understanding of how engineering, precision, and legacy connect on the road.

For the National Corvette Museum, the R8C program represents more than a delivery. It is a curated moment that joins owners to the larger story of America's Sports Car. Each vehicle delivered on Corvette Boulevard becomes part of the Museum's living mission: to preserve, educate, and celebrate the legacy of Corvette.

Newgarden's delivery was completed in Bowling Green, Kentucky—just one mile from the GM Bowling Green Assembly Plant where every Corvette has been built since 1981.
